- 2. The number of participants in each application is 1-4 persons.
- 3. Please provide adequate, correct and clear information. Incomplete application will not be processed.
- For organizations or school schools, please send the application with the required information directly to <u>npnc@afcd.gov.hk</u>. The number of participants should be under 20.
- 5. Each group shall arrange its own transportation to and leave from the Centre. Please arrive the centre 15 minutes before the start time of the guided tour.
- 6. Successful candidates will be notified by email.
- All education activities will be cancelled without prior notice when Typhoon Signal no. 3 or above, or any rainstorm or thunderstorm warning is in force two hours before the activities.
- 8. All outdoor activities will be cancelled when
 - O a tropical cyclone warning signal is hoisted
 - O there is a/an amber, red or black rainstorm warning
 - O a thunderstorm forecast/warning is issued
- All outdoor activities will be cancelled without prior notice when the Forecast of Health Risk of the Air Quality Health Index is Serious (AQHI Scale 10+) for General Stations. Indoor guided tours at Country Parks Visitor Centres will be held as usual.
- 10. Please treasure educational resources. If you decide to cancel the booking, please notify the Centre at your earliest convenience.
- 11. Participants are advised to bring drinking water, mosquito repellent and sunscreen. Attention must be paid to the following measures and codes.
 - O Wear suitable outdoor clothing
 - O Drink plenty of water
 - O Treasure our nature. Do not disturb wildlife nor collect plants
 - O Protect countryside, reduce waste production and "take your litter home"
